

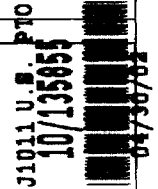

**ASSIGNMENT**

WHEREAS, I, DERALD RAY LANGHAM, of 7350 Seidel Road, San Antonio, Texas 78209, U.S.A., have invented certain new and useful improvements in a NON-DEHISCENT SESAME VARIETY S25, for which I am about to make application for United States Letters Patent, the said application having been executed on April 30, 2002 by me; and

WHEREAS, SESACO CORPORATION, (hereinafter referred to as "ASSIGNEE"), a corporation of the State of California, having a business address of 700 West Center Street, Paris, Texas 75460, U.S.A., is desirous of acquiring my entire right, title and interest in and to the invention, and in and to the said application and any Letters Patent that may issue thereon;

I also hereby sell and assign to said ASSIGNEE, its successors, assigns and legal representatives the full and exclusive right, title and interest to the invention disclosed in said application throughout the world, including the right to file applications and obtain patents, utility models, industrial models and designs for said invention in its own name throughout the world including all rights of priority, all rights to publish cautionary notices reserving ownership of said invention and all rights to register said invention in appropriate registries; and I further agree to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such right, title and interest in ASSIGNEE, its successors, assigns and legal representatives.

I also covenant that no assignment, sales agreement, or encumbrance has been or will be made or entered into which would conflict with this assignment and sale.

I hereby further agree that I will communicate to said ASSIGNEE, or to its successors, assigns and legal representatives, any facts known to me respecting any improvements; and, at the expense of said ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, make all lawful oaths, and generally do everything possible to vest title in said ASSIGNEE and to aid said ASSIGNEE, its successors, assigns and legal representatives to obtain and enforce proper protection for said invention in all countries.
