ASSIGNMENT

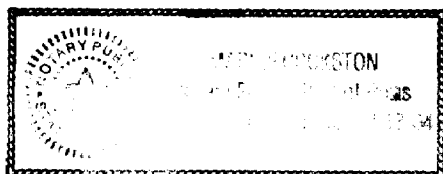

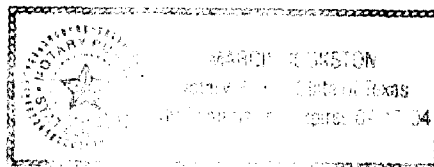

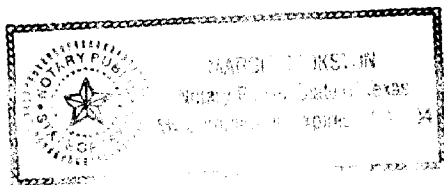
