WHEREAS, I, **Per Venge**, a citizen of Sweden, residing at Skolgatan 23, SE-753 12 Uppsala, Sweden (hereinafter referred to as "ASSIGNOR"), have invented **Use of Human Neutrophil Lipocalin (HNL) as a Diagnostic Marker and Anti-HNL-Antibody Preparation**, for which U.S. Patent No. 6,136,526 issued on October 24, 2000; and
