WHEREAS, Eiichi Hayashi residing at 324 Uetake-cho 1-chome, Saitama-shi, Saitama-ken, Japan (hereinafter referred to as Assignor), has invented certain new and useful improvements in **MECHANISM FOR RETAINING PLATEN GLASS USED TO READ ORIGINAL IN COURSE OF BEING FED IN IMAGE READER** for which an application for United States Letters Patent was filed on March 26, 2002, and assigned Serial No. 10/106,160.
