WHEREAS, SPYROTECH CORPORATION, incorporated in the state of Nebraska, with a place of business at 4930 Superior Street, Suite D, Lincoln, Nebraska 68504, is the owner by prior assignment of record in the records of the U.S. Patent and Trademark Office at Reel 10669, Frame 0391, of U.S. Patent No. 6,050,612 for COMPOSITE ASSEMBLY HAVING IMPROVED LOAD TRANSMISSION BETWEEN A FLEXIBLE TUBULAR PIPE SECTION AND A RIGID END FITTING VIA RESPECTIVE ANNULAR COUPLING GROOVES, issued April 18, 2000, ("the Patent") and all other rights in and to the invention described therein as set forth in said prior assignment;



NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I, John A. Wolf, as Trustee in Bankruptcy for SPYROTECH CORPORATION, have sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over, unto the said ZAKROFF INTERESTS LLC dba WOODLAND VENTURE GROUP, its successors, legal representatives and assigns, the entire right, title and interest in, to and under the said invention, and the said Patent and all divisions, renewals and continuations thereof, and all Letters Patent of the United States which may be granted thereon and all reissues and extensions thereof, and all applications for Letters Patent which have been or which may hereafter be filed for said invention in any country or countries foreign to the United States, and all Letters Patent which may be granted for said invention in any country or countries foreign to the United States and all extensions, renewals and reissues thereof and all rights of priority in any such country or countries based upon the filing of the said application for Letters Patent of the United States which are created by any law, treaty or international convention; and I hereby authorize and request the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said invention to the said ZAKROFF INTERESTS LLC, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith.
