# ASSIGNMENT

WHEREAS, I, Ihab M. Hekal, hereinafter referred to as ASSIGNOR, whose post office address is set forth below, have invented and own a certain invention entitled:

## MONOLITHIC COMPOSITION HAVING THE CAPABILITY OF MAINTAINING CONSTANT RELATIVE HUMIDITY IN A PACKAGE
