2 thereof; and I hereby authorize and request the Commissioner of Patents of the United  
3 States, and any Official of any country or countries foreign to the United States, whose  
4 duty it is to issue patents on applications as aforesaid to the said **TEBCO Pty Limited**,  
5 its successors, legal representatives and assigns, in accordance with the terms of this  
6 instrument.

8 **AND**, I hereby covenant that I have full right to convey the entire interest herein  
9 assigned, and that I have not executed and will not execute, any agreement in conflict  
10 herewith.


