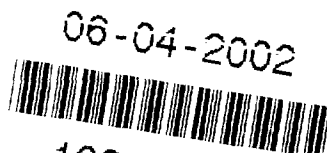

Acting by and through the State Board of Higher Education on Behalf of Oregon State University, or its successors and assigns, any facts known to us respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths, and do everything possible to aid the State of Oregon Acting by and through the State Board of Higher Education on Behalf of Oregon State University, its successors and assigns to obtain and enforce proper patent protection for said invention in this or any foreign country.
