ASSIGNMENT

WHEREAS, Matthew York (hereinafter "York"), residing at 630 West Eighth Avenue, Chico, California 95926 is the inventor and owner of United States Patent No. 5,850,340 (hereinafter, the "Patent"); and

WHEREAS, X10 Wireless Technology, Inc., is a Delaware state corporation having a principal address at 15200 52nd Avenue South, Seattle, WA 98188 (hereinafter "X10"); and

WHEREAS on or about October 22, 2001 York and X10 executed an agreement transferring the entire right, title, and interest in and to the Patent and its disclosed inventions to X10 and now wish to execute a simplified assignment document acknowledging the prior assignment and suitable for recording in the U.S. Patent and Trademark Office while leaving certain financial and other terms confidential;


NOW, THEREFORE, York assigns and transfers to X10 the entire right, title, and interest in and to the Patent and its disclosed inventions, and all provisional or nonprovisional patent applications or issued patents that have been or may be granted and that assert a common claim of priority, including without limitation all reissues, divisions, continuations, continuations-in-part, and extensions of the patent applications or patents, or any other form of protection for the inventions related to the Patent, in the United States and foreign countries. This assignment includes an assignment of all rights of action arising from the assigned subject matter; all claims for damages by reason of past and future infringement of the assigned subject matter; and the right to sue and collect damages for such infringement. All of the foregoing assigned rights are to be held and enjoyed by X10 for its own use and benefit and for its successors and assignees as the same would have been held by York had this assignment not been made. This agreement shall not supersede or otherwise serve to limit in any way any prior agreements between York and X10 dealing with assignment of the Patent.

The parties acknowledge the acceptance of the terms and conditions set forth in this Agreement through the signatures of their duly authorized representatives on the dates appearing under such signatures below.
