**ASSIGNMENT OF INVENTION AND PATENT RIGHTS THEREIN**

This Assignment is entered into by and between Western Atlas Inc., a Delaware corporation (hereinafter "WESTERN") and UNOVA IP CORP, a Delaware corporation (hereinafter "UNOVA").

WHEREAS, in 1995, employees of WESTERN invented a new and improved button wheel grinding machine ("Invention") and assigned their entire right, title and interest in and to said Invention and in and to their patent rights therein by an assignment of invention and of patent rights dated 5 June 1995; and,

WHEREAS, on 31 October 1997, WESTERN spun-off its industrial automation systems business to UNOVA; and,

WHEREAS, as part of that transaction, WESTERN desires to assign its entire right, title and interest in and to said Invention and in and to all patent rights therein to UNOVA and UNOVA desires to receive same from WESTERN;


NOW, THEREFORE, in consideration of the foregoing premises and for other good and valuable consideration, receipt of which is hereby acknowledged, WESTERN and UNOVA agree as follows:

WESTERN does hereby sell, assign, transfer and convey unto UNOVA, its successors and assigns, *nunc pro tunc*, having an effective date of October 31, 1997, the entire right, title and interest in and to said Invention and in and to any patent rights therein acquired by virtue of the assignment from the inventors dated 5 June 1995, including U.S. Patent No. 6,217,433 issued on 17 April 2001, and in the subject matter disclosed therein, for the United States of America and for all countries foreign thereto, including rights of priority under the International Convention of Paris (1883) as amended, and the entire right, title, and interest in and to any and all patent applications, patents, continuations, continuations-in-part, divisionals (including U.S. Patent Application Serial No. 09/793,164 filed on 26 February 2001 which claims priority to said '433 patent), and reissues based thereon which may be filed or granted therefor in the United States or any foreign country. The rights conveyed hereby shall include the right to sue for past infringement.
