ASSIGNMENT

WHEREAS, WE, STEPHEN CHARLES TROWELL, CHUNYAN LIAO, and PETER DAVID EAST, (herein called "ASSIGNORS"), residing at 3 Farrelly Close, Oxley, Australian Capital Territory 2903, Australia; 14 Beagle Street, Red Hill, Australian Capital Territory 2603, Australia; and 3 Quinn Street, O'Connor, Australian Capital Territory 2602, Australia respectively, are the inventors of the invention "FEEDING ASSAY FOR IDENTIFYING NEMATICIDAL COMPOUNDS" for which we have executed an application for a Patent of the United States, filed 11/30/00 (Int'1), Serial No. 10/148,352;

AND WE HEREBY authorize and request the Commissioner of Patents and Trademarks of the United States, and any official of any country or countries foreign to the United States whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument;

AND WE HEREBY covenant and agree that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith;

AND WE HEREBY authorize the above-mentioned assignee or its legal representative to insert in this instrument the filing date and serial number of our said application or any other information that may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.

AND WE HEREBY further covenant and agree that we will communicate to the said ASSIGNEE, its successors, legal representatives and assigns, any facts known to us respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing, reissue and foreign applications, make all rightful oaths, and generally do everything possible to aid the said ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper protection for said invention in all countries.
