

ASSIGNMENT

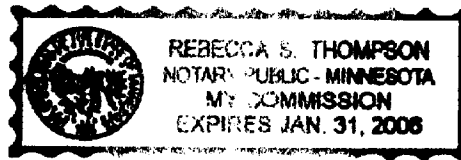

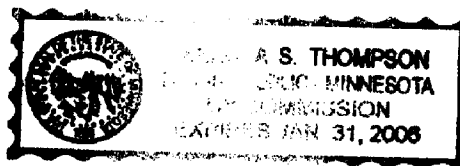
