KNOW ALL MEN BY THESE PRESENTS, That Whereas

instruments, and do all other acts which, in the opinion of counsel for ASSIGNEE, may be necessary or convenient to secure the grant of Letters Patent to ASSIGNEE, its successors and assigns, or its nominees, in the United States and in all other countries where ASSIGNEE may desire to have the said inventions, or any of them, patented, with specifications and claims in such form as shall be approved by counsel for ASSIGNEE, and to vest and confirm in ASSIGNEE, its successors and assigns, or its nominees, the full and complete and equitable title to all such Letters Patent, without further consideration than now paid but at the expense of ASSIGNEE, its successors or assigns.
