


**RESTATED CERTIFICATE OF INCORPORATION
OF
SARNOFF DIGITAL COMMUNICATIONS, INC.**

(Pursuant to Section 242 of the
Delaware General Corporation Law)

Sarnoff Digital Communications, Inc., a Delaware corporation (the "Corporation"), does hereby amend its Restated Certificate of Incorporation as set forth below and certifies as follows:

FIRST: The Restated Certificate of Incorporation of the Corporation (the "Certificate") was filed in the Office of the Secretary of State of the State of Delaware on March 26, 1999.

SECOND: The Certificate is hereby amended by striking out Article FIRST thereof and by substituting in lieu of said sentence the following new Article FIRST in its entirety as follows:

"FIRST: The name of the corporation is NxtWave Communications, Inc."

THIRD: This Certificate of Amendment to the Certificate was duly approved at a special meeting of the Board of Directors and by the written consent of the stockholders of the Corporation entitled to vote in accordance with Sections 228 and 242 of the Delaware General Corporation Law.
