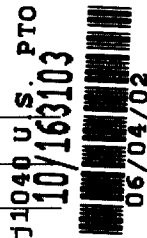

I hereby authorize and request the Commissioner of Patents and Trademarks to issue any and all patents that may be granted for said inventions to Assignee, and I agree that I and my successors, assigns or legal representatives thereof, shall be legally bound without additional compensation (except for any statutory fee applicable to witnesses), but without cost to me, to promptly communicate to Assignee or its representatives, all facts known to me or in my possession respecting said inventions whenever requested, to testify in any legal proceedings, to sign all lawful papers, execute all divisional, continuing and reissue applications, to make all rightful oaths and to generally aid my said Assignee, its successors and assigns, as and when requested by them, in obtaining in the name of the Assignee and in enforcing proper patent protection for said inventions on behalf of the Assignee, in the United States and all countries foreign thereto.

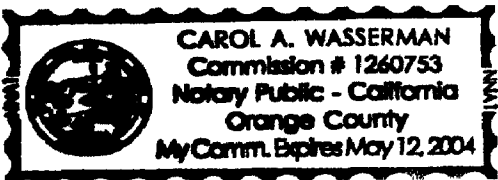
I hereby covenant that no assignment, sale, agreement or encumbrance has been or will be made or entered into which conflicts, or would be in conflict, with this Assignment.
