NOTICE OF EXCLUSIVE PATENT LICENSE

The Parties hereto hereby agree as follows:



IN WITNESS WHEREOF, the Parties hereto have caused this Notice of Exclusive License to be executed by their duly authorized representatives as of the date first above written.


