**Assignment**

WHEREAS, Reijo Jokinen of Raisio, Finland; Antti Komulainen of Keuruu, Finland; and Kari Juppi of Palokka, Finland (hereinafter "ASSIGNORS"), have invented a Method and Apparatus in the Drying Section of a Paper Machine or the Like, which was filed as PCT/FI00/00129 on February 21, 2000, and for which a corresponding application is being made for Letters Patent in the United States; and

all additional papers that may be reasonably requested by ASSIGNEE to fully carry out the terms of this Assignment.




