**ASSIGNMENT**

WHEREAS, Hidezi Satoh and Takashi Kimura, hereinafter called the "Assignors," have made the invention described in the United States patent application entitled MAGNETIC HEAD INCLUDING SLIDER ELECTRICALLY CONNECTED TO FLEXURE WITH CONDUCTIVE RESIN FILM, for a full description of which reference is here made to an application for Letters Patent of the United States filed on March 15, 2002, and assigned Application Serial No. 10/099,911;
