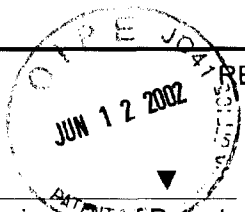


ASSIGNMENT BEFORE PATENT


