WHEREAS, WE, AVI PENNER, a citizen of ISRAEL, and LONE WOLINSKY, a citizen of ISRAEL (hereinafter referred to as "ASSIGNORS"), have invented and own a certain invention entitled SYSTEMS AND METHODS FOR DEPLOYING A BIOSENSOR IN CONJUNCTION WITH A PROSTHESIS for which application for Letters Patent of the United States of America has been filed on March 10, 2000, assigned Serial No. 09/522,370; and

said Letters Patent or any legal equivalent thereof to said ASSIGNEE, its successors and assigns, in accordance with this Assignment.


ASSIGNORS hereby covenant that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Agreement;
