PATENT ASSIGNMENT TO CORPORATION WORLDWIDE

WHEREAS,

1. Pekka Marjelund residing at Kirjurinkuja 1 E 80, FIN-02600 Espoo, Finland and a citizen of Finland;
2. Jari Hartikainen residing at Metsarinne 7 B, FIN-04220 Kerava, Finland and a citizen of Finland;
