

AND Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks to issue any and all Letters Patent or Patents of the United States on said Patents (and inventions claimed therein) to Assignee as Assignee of the entire right, title and interest therein and thereto, and Assignor hereby covenants that it has full right to assign, transfer and convey the entire right, title and interest herein assigned, and that it has not executed, and will not execute, any agreements inconsistent herewith.
