ASSIGNMENT

Assignment made by George D. Such duty includes prompt execution of all papers, to be prepared at the expense of assignee, that are deemed necessary or desirable by assignee to perfect the conveyed rights.

The terms, covenants, and provisions of this assignment shall insure to the benefit of assignee, its successors, assigns, and/or other legal representatives, and shall be binding on inventor, his heirs, assigns, and other legal representatives.

Inventor warrants and represents that he has not entered into any assignment, contract, or understanding in conflict with this assignment.


