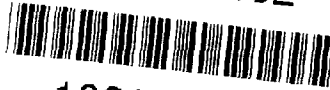

ASSIGNMENT

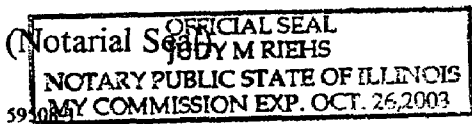
