**Assignment of Invention**

WHEREAS, WE, Eric STREICHER of 45 rue Raphael Corby, 78220 Viroflay, France; John FOSS of 932 East Bailey Road, Naperville, Illinois 60565; Mahendra L. JOSHI OF 369 Natalie Dr., Allentown, PA. 18104; and Harley A. BORDERS of 9687 South Bellmore Place, Highlands Ranch, CO. 80126; respectively, have invented certain new and useful improvements in: **Systems and Methods for Increasing Production of Spheroidal Glass Particles in Vertical Glass Furnaces** for which an application for Letters Patent was filed on **October 19, 2001**, having Serial No. **09/981,740**;
