

THIS ASSIGNMENT, by Maynard Handley (hereinafter referred to as the assignor), a resident of Cupertino, California, witnesseth:

WHEREAS, said assignor has invented certain new and useful improvements in METHOD AND APPARATUS FOR INVERSE DISCRETE COSINE TRANSFORM, set forth in an application for Letters Patent of the United States, bearing Serial No. 09/756,970 and filed on 1/9/01; and

WHEREAS, Apple Computer, Inc., a corporation duly organized under and pursuant to the laws of California and having its principal place of business at One Infinite Loop, Mail Stop: 38-PAT, Cupertino, California (hereinafter referred to as the assignee) is desirous of acquiring the entire right, title and interest in and to said inventions and said application for Letters Patent of the United States, and in and to any Letters Patent or Patents, United States or foreign, to be obtained therefor and thereon:

AND for the same consideration, said assignor hereby covenants and agrees to and with said assignee, its successors, legal representatives and assigns, that said assignor will, whenever counsel of said assignee, or the counsel of its successor, legal representatives and assigns, shall advise that any proceeding in connection with said inventions, or said application for Letters Patent, or any proceeding in connection with Letters Patent for said inventions in any country, including interference proceedings, is lawful and desirable, or that any division, continuation or continuation-in-part of any application for Letters Patent or any reissue or extension of any Letters Patent, to be obtained thereon, is lawful and desirable, sign all papers and documents,

take all lawful oaths, and do all acts necessary or required to be done for the procurement, maintenance, enforcement and defense of Letters Patent for said inventions, without charge to said assignee, its successors, legal representatives and assigns, but at the cost and expense of said assignee, its successors, legal representatives and assigns.

AND said assignor hereby requests the Commissioner of Patents to issue said Letters Patent of the United States to said assignee as the assignee of said inventions and the Letters Patent to be issued thereon for the sole use of said assignee, its successors, legal representatives and assigns.
