

ASSIGNMENT

WHEREAS, Peter Mykola Scarrott, hereinafter called the "Assignor", has made the invention described in the United States patent application entitled Indicating Device For Aerosol Container, for a full description of which reference is here made to an application for Letters Patent of the United States filed on March 21, 2002, and assigned Application Serial No. 10/104,988;


