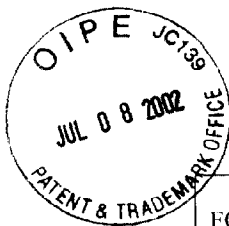

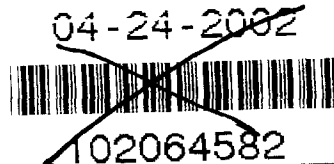

WHEREAS, Advance Sports, Inc. ("Assignor"), a Washington corporation with an address of 2904 Grant Road, East Wenatchee, WA 98802, is the assignee of the patent related to a Automated Hole-In-One Recording System, for which Letters Patent of the United States have been issued, and which may be identified in the United States Patent Office by Patent No. 5,102,140, granted April 7, 1992;

Upon said consideration Assignor does hereby covenant and agree with the said Assignee, its successors and assigns, that Assignor will not execute in writing or do any act whatsoever conflicting with these presents, and that Assignor will at any time upon request, without further or additional consideration, but at the expense of the said Assignee, its successors and assigns, execute such additional writings and do such additional acts as said Assignee, its successors and assigns, may deem necessary or desirable to perfect the Assignee's enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, divisional, reissued or extended Letters Patent of the United States, or of any and all foreign countries on said invention, and in enforcing any rights occurring as a result of such applications or patents, by giving testimony in any proceedings or transactions involving such applications or patents.

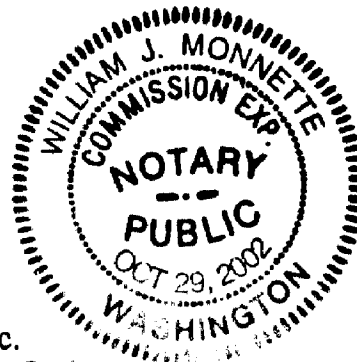

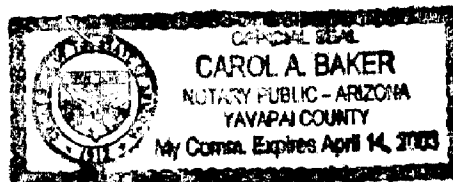
