(4) the Assignor hereby further covenants and agrees that the Assignor will, without further consideration, communicate with Assignee, its successors and assigns, any facts known to the Assignor respecting this invention, and testify in any legal proceeding, sign all lawful papers when called upon to do so, execute and deliver any and all papers that may be necessary or desirable to perfect the title to this invention in said Assignee, its successors and assigns, execute all divisional, continuation, and reissue applications, make all rightful oaths and generally do everything possible to aid Assignee, its successors, and assigns, to obtain and enforce proper patent protection for this invention in the United States and any foreign country, it
