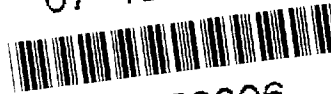


AGREEMENT
