I HEREBY authorize and request the Commissioner of Patents to issue said United States Patent to said assignee, of the entire right, title, and interest in and to the

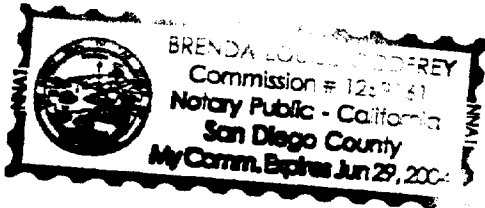
