In consideration of the sum of One Dollar (US\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the undersigned **SiRF Technology Holdings, Inc.** (a Delaware corporation having a principal place of business at 148 E. Brokaw Road, San Jose, California 95112, USA) (hereafter referred to as ASSIGNOR), having right, title and interest in a certain invention entitled **DOPPLER CORRECTED SPREAD SPECTRUM MATCHED FILTER**, for which an application for a United States Patent was filed on **September 1, 1998**, given Application No. **09/145,055**, was issued on **March 28, 2000**, and given Patent No. **6,044,105**, assigns, sells, and otherwise transfers by this instrument to **SiRF Technology, Inc.** (a Delaware corporation desirous of acquiring the entire right, title and interest in the same and having a principal place of business at 148 E. And for the consideration, ASSIGNOR hereby assigns to ASSIGNEE the entire right, title and interest in the invention or improvements in and for all foreign countries, and any and all applications for foreign Patent that may evolve therefrom, including all priority rights under the International Convention, and agrees to have executed, at the request of ASSIGNEE, all documents in connection with any and all applications for foreign Patent therefor.
