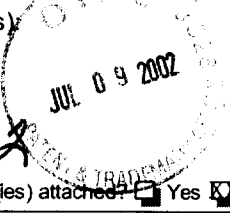

## ASSIGNMENT

**WHEREAS**, I, Sergio J. Orozco, a citizen of the United States, residing at 6040 Blvd. East, Suite 26G, West New York, NJ 07093, have invented a certain new, original and ornamental design disclosed in an application for Design Patent of the United States titled LIGHT FIXTURE (hereinafter referred to as "said application"), said application having been filed on May 14, 2002 and assigned application Serial No. 29/160,655.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which I hereby acknowledge, I have sold, assigned, transferred and set over, and by these presents hereby sell, assign, transfer and set over to the Assignee all right, title and interest in, to and under said design and said application, including the right to apply for a patent in the United States of America and in any and all foreign countries on said design, and any and all other applications for patent on said design, in whatsoever countries, including all divisional, renewal, substitute, continuation, continuation-in-part and convention applications based in whole or in part upon said design and any invention embodied thereby, and any and all patents which may issue thereon in the United States and foreign countries and any and all reissues, extensions, renewals, divisions, continuations or continuations-in-part of patents granted for said design or upon said applications, to the full term or terms for which said patent may be issued, and every priority right that is or may be predicated upon or arise from said design, said application and said any patent issuing thereon, the same to be held and enjoyed by the Assignee for its own use and benefit fully and entirely as if the same would have been held and enjoyed by me had this Assignment not been made. I hereby authorize the Assignee to file patent applications in any and all countries on said design in my name, or in its name, or otherwise as the Assignee may deem advisable, under the International Convention or the applicable laws of a particular jurisdiction.

By this Assignment, I have hereby sold, transferred and set over and by these presents hereby sell, assign, transfer and set over to the Assignee all interest in copyright in and to said design, including the right to register said copyright as assignee thereof. I hereby waive my rights of attribution and integrity under 17 USC § 106A with respect to said design, for any and all uses thereof.

I hereby authorize the responsible official of the United States Patent and Trademark Office and the Register of Copyrights, and any official of any other country empowered to issue patents or register copyrights, to record this Assignment, and to issue or transfer all patents, registrations of copyright or any and all indicia of intellectual property rights on said design to the Assignee as owner of all right, title and interest therein, or otherwise as the Assignee may direct, in accordance with the terms of this Assignment.


