WHEREAS, We, SUVENDU BHATTACHARYA, a citizen of India and resident of Central Food Technological Research Institute, Mysore, India; RANGASAMY BABY LATHA, a citizen of India and resident of Central Food Technological Research Institute, Mysore, India; THOTADAMOOLE RAMESH a citizen of India and resident of Central Food Technological Research Institute, Mysore, India; APPU RAO APPU RAO GOPALA RAO, a citizen of India and resident of Central Food Technological Research Institute, Mysore, India; and VISHWESHWARIAH PRAKASH, a citizen of India and resident of Central Food Technological Research Institute, Mysore, India (hereinafter referenced as ASSIGNORS), have invented a certain new and useful invention entitled "CEREAL GRIT FOOD PRODUCT HAVING ENHANCED SHELF LIFE AND HIGH PROTEIN CONTENT", for which an application was filed in the U.S. Patent and Trademark Office on March 25, 2002 under serial number 10/105,879.

AND, WE HEREBY agree to transfer a like interest, upon the request of said ASSIGNEE, its successors, assigns, and legal representatives, and without further remuneration, in and to any improvements, and any applications for patent based thereon, growing out of or related to the said invention; and We agree to execute any papers by the said ASSIGNEE, its successors, assigns, and legal representatives, deemed essential to ASSIGNEE's full protection and title in and to the invention hereby transferred.

AND, WE HEREBY covenant that we have the full right to convey the interest assigned by this Assignment, and we have not executed, and will not execute any agreement in conflict with this Assignment;

AND, WE HEREBY further covenant and agree that we will, without further consideration, communicate with ASSIGNEE, its successors and assigns, any facts known to us respecting this invention, and testify in any legal proceeding, sign all lawful papers when called upon to do so, execute and deliver any and all papers that may be necessary or desirable to perfect the title of this invention in said ASSIGNEE, its successors and assigns, execute all original, divisional, continuation, substitute, and reissue applications of any sort, make all

rightful oaths and generally do everything possible to aid ASSIGNEE, its successors and assigns, to obtain and enforce proper patent protection for this invention in the United States and any foreign country, it being understood that any expense incident to the execution of such papers shall be borne by the ASSIGNEE, its successors and assigns.
