NOW THEREFORE, To All Whom It May Concern, Be it known that:

1. The ESTATE does hereby distribute, assign, transfer, and set over, unto the FAMILY TRUST, its successors, assigns, and legal representatives, the entire right, title, and interest for the United States, its territories, dependencies, and possessions, in and to said Patent Properties and any confirmations, divisions, continuations, reexaminations, reissues, or extensions thereof; the same to be held and enjoyed by the FAMILY TRUST, its beneficiaries, successors, assigns, and legal representatives, as fully and entirely as the same would have been held and enjoyed by the ESTATE had this distribution and transfer not been made, together with all claims for damages by reason of past infringement of said Patent Properties with the right to sue for and collect the same for its own use and for the use of its beneficiaries, successors, assigns, and legal representatives.

2. Upon receipt of the entire right, title, and interest in and to said Patent Properties and any confirmations, divisions, continuations, reexaminations, reissues, or extensions thereof, the FAMILY TRUST does hereby distribute, assign, transfer, and set over, unto the FAMILY TRUST BENEFICIARIES, their heirs, successors, assigns, and legal representatives, the entire right, title and interest in and to said Patent Properties and any confirmations, divisions, continuations, reexaminations, reissues, or extensions thereof; the same to be held and enjoyed by the FAMILY TRUST BENEFICIARIES, their heirs, successors, assigns, and legal representatives, as fully and entirely as the same would have been held and enjoyed by the FAMILY TRUST had this distribution and transfer not been made, together with all claims for damages by reason of past infringement of said Patent Properties with the right to sue for and collect the same for their own use and for the use of their heirs, successors, assigns and legal representatives.

3. Upon receipt of the entire right, title, and interest in and to said Patent Properties and any confirmations, divisions, continuations, reexaminations, reissues, or extensions thereof, the FAMILY TRUST BENEFICIARIES do hereby distribute, assign, transfer, and set over unto (a) DAY O. MOUNT, his heirs, successors, assigns, and legal representatives, a one-half (1/2) undivided interest in and to said Patent Properties and any confirmations, divisions, continuations, reexaminations, reissues, or extensions thereof; (b) HJALMAR J. NELSON, his heirs, successors, assigns, and legal representatives, a one-fourth (1/4) undivided interest in and to said Patent Properties and any confirmations, divisions, continuations, reexaminations, reissues, or extensions thereof; and (c) ERICA O. NELSON, her heirs, successors, assigns, and legal representatives, a one-fourth (1/4) undivided interest in and to said Patent Properties and any confirmations, divisions, continuations, reexaminations, reissues, or extensions thereof; the same to be held by each of DAY O. MOUNT, HJALMAR J. NELSON, and ERICA O. NELSON, as fully and entirely as the same would have been held and enjoyed by the FAMILY TRUST BENEFICIARIES had this distribution and

transfer not been made, together with all claims for damages by reason of past infringement of said Patent Properties with the right to sue for and collect the same for the benefit of their use and for the use of their heirs, successors, assigns and legal representatives.

4. The ESTATE, the FAMILY TRUST, the FAMILY TRUST BENEFICIARIES, and the WHITNEY ESTATE BENEFICIARIES authorize and request the Commissioner of Patents and Trademarks of the United States to issue any confirmations, divisions, continuations, reexaminations, reissues, or extensions of said Patent Properties, to DAY O. MOUNT, HJALMAR J. NELSON, and ERICA O. NELSON, as to their respective interests.

5. The ESTATE, the FAMILY TRUST, the FAMILY TRUST BENEFICIARIES, and the WHITNEY ESTATE BENEFICIARIES agree to execute all papers necessary in connection with any interference, which may be declared concerning said Patent Properties, or any confirmation, division, continuation, reexamination, or reissue thereof, and to cooperate with DAY O. MOUNT, HJALMAR J. NELSON, and ERICA O. NELSON, in every way possible in obtaining evidence and going forward with such interference.

6. The ESTATE, the FAMILY TRUST, the FAMILY TRUST BENEFICIARIES, and the WHITNEY ESTATE BENEFICIARIES covenant that each has full right to convey the interest herein distributed or assigned and that neither has executed and that neither will execute any agreement in conflict herewith.

7. The ESTATE, the FAMILY TRUST, the FAMILY TRUST BENEFICIARIES, and the WHITNEY ESTATE BENEFICIARIES agree to perform all affirmative acts which may be necessary to maintain or confirm by reissue or reexamination a grant of a valid United States patent to DAY O. MOUNT, HJALMAR J. NELSON, and ERICA O. NELSON, for any of said Patent Properties.

8. The ESTATE, the FAMILY TRUST, the FAMILY TRUST BENEFICIARIES, and the WHITNEY ESTATE BENEFICIARIES grant the firm of KAUFMAN & CANOLES of Norfolk, Virginia the power to insert on this Assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.
