And **ASSIGNOR** further covenants and agrees that it will communicate to **ASSIGNEE**, its successors, assigns or other legal representatives, any facts known to it respecting the Patent Rights, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid **ASSIGNEE**, its successors, assigns or other legal representatives to obtain and enforce proper patent protection for said Patent Rights.
