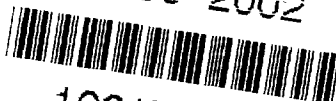

PATENT ASSIGNMENT




