WHEREAS, We, Michael J. Hundt, resident of Double Oak, Denton County, Texas, citizen of the United States of America and Tiao Zhou, resident of Irving, Dallas County, Texas, citizen of People's Republic of China, have invented certain new and useful improvements in a "APPARATUS AND METHOD FOR ATTACHING AN INTEGRATED CIRCUIT SENSOR TO A SUBSTANCE" disclosed in an application for United States Letters Patent (Application No. \_\_\_\_\_, filed \_\_\_\_\_), said application having been executed concurrently herewith;

divisional, continuation, continuation-in-part, reissue and substitute applications, and make all lawful oaths, and generally do everything possible to vest title in said ASSIGNEE and to aid said ASSIGNEE, its successors, assigns and legal representatives to obtain and enforce proper protection for said invention in all countries.
