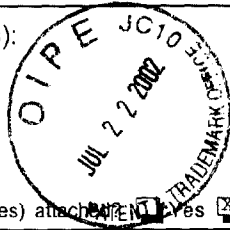

ASSIGNMENT

WHEREAS, I, Gerd Lichter, of Radeburg, Germany, hereinafter ("Assignor"), have invented certain new and useful improvements in METHOD FOR FABRICATING AN INTEGRATED CIRCUIT for which application for a U.S. Letters Patent was made on May 30, 2002 as Application Serial No. 10/158,465 (based on German application no. 10126294.9 filed May 30, 2001).


Assignor hereby requests that said Letters Patent be issued in accordance with this assignment.


