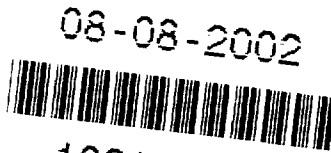




**ASSIGNMENT**

WHEREAS, I, **NORMAN M. FEDALIZO**, residing at 2315 Songbird Lane, Rowland Heights, California 91748, along with Prabir Bhattacharya and Toshiharu Motokubota, have invented certain new and useful improvements disclosed in an application for United States Letters Patent entitled **PROCESS FOR INACTIVATION OF LYOPHILIZED BLOOD PROTEINS**, Application No. 09/166,875, filed October 6, 1998;

AND WHEREAS **ALPHA THERAPEUTIC CORPORATION**, a California corporation, having a place of business at 5555 Valley Boulevard, Los Angeles, California 90032 (hereafter, together with any successors, legal representatives or assigns thereof, called "ASSIGNEE") wants to acquire the entire right, title and interest in and to said improvements and application.

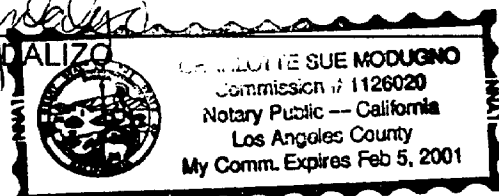

AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith;

AND I HEREBY further covenant and agree that I will communicate to ASSIGNEE any facts known to me respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute and reissue applications, make all rightful oaths and generally do everything possible to aid ASSIGNEE to obtain and enforce proper patent protection for said improvements in all countries.

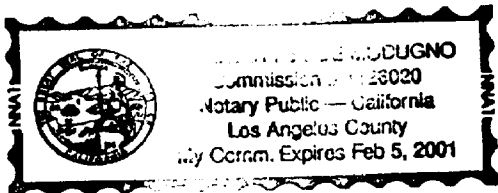
