WHEREAS, We, JUSTIN K. BRASK, STEVEN J. KEATING, MARK L. DOCZY, and TRAVIS J. DELASHMUTT, are joint inventors of SELECTIVE ETCHING OF POLYSILICON, application for United States Letters Patent which is executed of even date herewith; and




