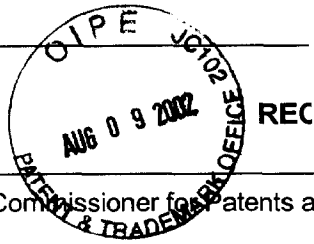


part, reissue or other application, to Assignee, its successors and assigns, as the assignee of the entire interest in said Invention.
