JOINT TO CORPORATE ASSIGNMENT

INTEGRATED MULTIPLE-UP/DOWN CONVERSION RADAR TEST SYSTEM

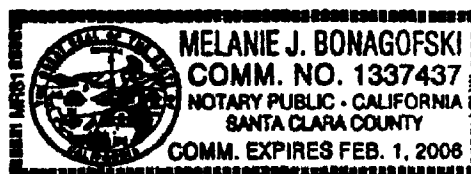

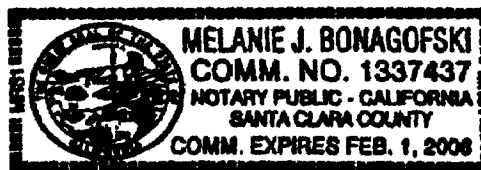
