ASSIGNMENT

In return for a valuable consideration, the receipt and sufficiency of which is hereby acknowledged, we, Joel J. Heck of Mulvane, Kansas, Mark W. Palmer of Peru, Kansas, and Earl V. successors, assigns and nominees to obtain and enforce proper protection for said inventions and improvements in all countries; said inventions, applications and Letters Patent to be held and enjoyed by CESSNA AIRCRAFT COMPANY for its own use and behoof and for its legal representatives, to the full end of the term for which such Letters Patent may be granted, as fully and entirely as the same would have been held by us had this assignment and sale not been made.


