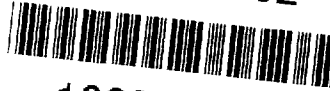

IT IS HEREBY ORDERED that:


- 1) Plaintiff's motion is granted in part;


