

ASSIGNMENT

WHEREAS, The Illinois Institute of Technology (herein called IIT) has the right to acquire and did acquire rights in an invention entitled "Metallic Substrates for High Temperature Superconductors" described in U.S. Patent Application No. 09/568,890 filed May 11, 2000, naming as inventors Thomas G. Truchan, Dean J. Miller, Kenneth C. Goretta, Uthamalingam Balachandran, and Robert P. Foley.

WHEREAS, by document attached hereto as Appendix A, and hereby incorporated by reference, Robert P. Foley (herein called the INVENTOR) has assigned and transferred his entire right, title and interest in the INVENTION to IIT.

WHEREAS, the INVENTION is a Subject Invention under Prime Contract W-31-109-ENG-38 between the University of Chicago, as Operator of Argonne National Laboratory (herein called the UNIVERSITY), and the U.S. Department of Energy, and the UNIVERSITY has requested that the IIT assign its rights and title in the INVENTION to the UNIVERSITY.

NOW THEREFORE, IIT hereby assigns and transfers to the UNIVERSITY all its right title and interest throughout the world in the INVENTION and to any and all Letters Patent where ever they may be granted thereon as well as reissues and extensions of said Letters Patent; the same to be held to the full end of the term or terms for which said Letters Patent are or may be granted, reissued, or extended, as fully and entirely as the same would be held by IIT had this assignment not been made.

IIT agrees to make, execute, and deliver or have the INVENTOR make, execute and deliver unto the UNIVERSITY any and all papers, documents, affidavits, renewals, divisions and reissue applications, statements and other instruments in such usual and other forms, terms, and contents as may be required or incident to the prosecution or conduct of any and all applications, before as well as after the issuance of any Letters Patent thereon, or in the adjustment or settlement of any interferences or other actions or proceedings that said application may encounter or in which they may become involved.

As consideration for the above assignment and assistance, the UNIVERSITY hereby agrees that the INVENTOR will share in any distribution of royalties arising from any patent application claiming the INVENTION and naming the INVENTOR as an inventor, such share to be equal to the share of each of the inventors named in such patent application that are employed by the UNIVERSITY.




ASSIGNMENT


