WHEREAS, Robert G. NOW, THEREFORE, in consideration of One Dollar(\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, CLUFF hereby sells, assigns and sets over to BUNZL, its successors and assigns, his entire right, title and interest in and to the Kuflinks patents and the Missing Link patents, and all divisions, reissues, substitutions, continuations and extensions thereof; and CLUFF hereby authorizes and requests the Commissioner of Patents and Trademarks to issue all patents resulting therefrom, insofar as his interest is concerned, to BUNZL.

CLUFF also hereby sells and assigns to BUNZL, its successors and assigns, all of his foreign rights to the inventions disclosed in the Kuflinks patents and the Missing Link patents, if any, in all patent-granting countries of the world, including the right to file applications and obtain patents for said inventions in said countries and claim priority in said countries under the terms of the International Convention for the Protection of Industrial Property, and CLUFF further agrees to

execute any and all patent applications, assignments, affidavits, and other papers necessary to perfect such patent rights.

CLUFF also hereby agrees to communicate to BUNZL, its successors, assigns and representatives, any facts known to him respecting inventions disclosed in the Kuflinks and Missing Link patents, and at the request and expense of BUNZL, to testify in any legal proceedings, sign all lawful papers, execute all divisionals, reissues, substitute, reexamination and continuation applications, make all lawful oaths, and generally do everything possible to aid BUNZL, its successors, assigns and representatives, to obtain and enforce proper patent protection for said inventions in all countries.

CLUFF hereby grants Marvin R. Stern, Registration No. 20,640, Harvey B. Jacobson, Jr., Registration No. 20,851; D. Douglas Price, Registration No. 24,514; John Clarke Holman, Registration 22,769; Allen S. Melser, Registration No. 27,215, Michael R. Slobasky, Registration No. 26,421; Jonathan L. Scherer, Registration No. 29,851, Irwin M. Aisenberg, Registration No. 19,007; and William E. Player, Registration No. 31,409, the power to insert on this Assignment document any further identification which may be necessary or desirable in order to identify any patent or otherwise comply with the rules of the United States Patent and Trademark Office for recordation of this document.

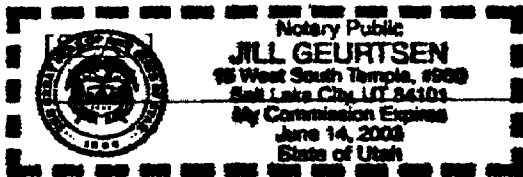
