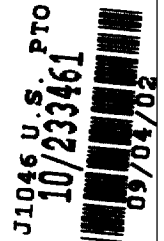


## ASSIGNMENT JOINT


