

WHEREAS, Susumu Mizuhara, Arata Nakamura and Hiroaki Nakanishi, all of Kyoto, Japan and Toshiaki Koya of Osaka, Japan, hereinafter referred to as "Assignors," have invented certain new and useful improvements as described and set forth in an application for Letters Patent of the United States entitled PHOTOELECTRIC SENSOR; and have executed an application for a United States patent disclosing and identifying the invention on the 24th day of April, 2002, and having Serial Number 10/132,068 and filing date of April 24, 2002; and
