





all rights to publish cautionary notices reserving ownership of said invention and all rights to register said invention in appropriate registries; and

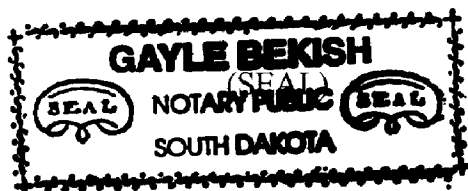
